Security regimes are international institutions designed to prevent war. One of the main ways they attempt to do this is by increasing transparency -- what adversaries know about each other's intentions and capabilities. My book answers the questions "How much do security regimes increase transparency?" and "How much do these efforts to increase transparency influence the likelihood of war?" It is often assumed that increased transparency reduces unwarranted fears, misperceptions, and miscalculation, but scholars have not thoroughly examined how transparency is provided or how it operates in practice. At the same time, security regimes in general are understudied, and theoretically-informed analyses of peacekeeping are rare. To fill these gaps, I test hypotheses about transparency with case studies of two regimes: the Concert of Europe and U.N. peacekeeping. My findings help us learn how to provide transparency and predict its effects.
