#### **Research in Progress**

Political Order and the Spartan Ideal: An Ancient Debate for a Time of Crisis

The present study examines the contest between the champions and critics of the *politeia*, "regime" or "constitution, generally attributed to the legendary Spartan lawgiver Lycurgus. This contest, I argue, is central to the classical understanding of the foundations of political order, but also alive in current debates about political order arising from theoretical critiques of liberal constitutionalism and practical crises such as the collapse of new democracies, deepening factionalism in established ones, and the wars in Ukraine and the Middle East.

This study examines the ways in which social science informs matters of political deliberation and judgment, as well as its limits in doing so. It seeks to clarify the kinds of questions most amenable to empirical analysis and those requiring the kind of prudential judgment that is honed through experience and exemplified in classical humanism.
